American Maltese Association Vendor Information Sheet

**The total fee for all three days of the event is only \$200/table.
Secure your reservations early. Space is limited.**

- Please understand that we can only reserve your space upon receipt of full payment, which must be **received** no later than July 15, 2008. Vendor Fees are **non-refundable** and **cannot** be applied to another Specialty.
- The hotel will provide eight-foot (8') tables, draped with a full-length skirt.
- Power outlets are available but must be shared with other vendors. So please bring a power strip and extension cord(s). If you require power do be sure to note that requirement on the Reservation Form.
- Space assignments will be made by the Vendor Chairman.
- The Hotel will permit vendors to ship items to the hotel with the following restrictions:
 - Boxes may be shipped up to 3 days prior to the event
 - All boxes should be shipped to the hotel and marked with the vendor's name or business name. You must clearly mark the boxes as part of the AMA convention. The hotel will store the boxes in a room set aside for AMA storage.
- The Thomas Edison Hotel will offer the AMA room rate to all participating vendors. Please let the hotel know you are with the AMA block to get the discount.
- **ALL** Space Assignments will be made by Vendor Chairman
- Neither the Thomas Edison Hotel nor the AMA will accept any responsibility for damage or for lost/stolen items
- Set-up will commence no earlier than 2:00 pm, Monday, September 8th and your area must be completely cleared **immediately following** judging on September 11th.
- ALL vendors are asked to donate an item for the AMA Auction. These items should be marked and given to the Vendor Chairman.
