Guidelines & Regulations for Show Site & Hotel

Care for the Show Site and Hotel facilities is of the utmost importance to the AMA. Any individual or individuals who violate these rules as spelled out below, and/or commit any other actions which may be considered "prejudicial to the sport of purebred dogs" will be dealt with in accordance with the American Kennel Club rules and will be summoned to an Event Committee Hearing. Good show sites are extremely hard to find and exhibitors and spectators need to take care of them to ensure that we will be welcomed back. These Show Site Rules will be enforced by Hotel Management and AMA

Your room may be randomly inspected to insure compliance with the following:

- Exhibitors shall be responsible for any damage done by their dogs to the show site, hotel facilities or to any individual or animal at this show site. Dogs may not be kept in rooms which are registered as "Dogless"
- Any and all rooms are subject to inspection at any time. You are responsible for keeping your hotel room and other site facilities in good condition.
- Dogs must be crated when left alone in the room. Dogs shall not be allowed to run free in your room nor may you confine them in the bathroom. NO EXCEPTIONS!
- Place plastic sheeting under all crate, x-pens & other equipment for confining your dog(s)
- Dogs must be kept quiet in the hotel rooms
- Any time your dog is not confined in a crate; please use a leash
- Use appropriate bags for doggie trash, not hotel trash cans
- Do not interfere with hotel housekeeping functions by using "Do Not Disturb" signs to restrict access to rooms with dogs inside
- Do not use hotel towels for dog grooming
- We're fortunate to have grass areas as dog exercise areas. Dogs must be exercised in designated areas only. Please pick up after your dogs. Use containers provided for waste disposal. Anyone that allows their dogs to exercise in other areas will be in violation of the Specialty Rules.
- No puppies less than 6 months old will be allowed in the hotel. There will be no whelping of puppies in the hotel.
- Some areas of the hotel are off-limits to dogs. These include: All areas that serve food and beverages, Gift Shop, Lobby & Registration Tables. Recreation area including the Pool and Health and Fitness Room.

RV Parking
